## **Disability Compensation:**


 discharged under conditions other than dishonorable



- injury incurred or aggravated in service in line of duty
- disability not result of willful misconduct or abuse of alcohol or drugs
- does NOT have to be in combat!

## What is a disability?

 Injury, disease, or condition that would impair the average civilian in earning a living



#### Service Connected Disabilities

- A 0% rating still documents disability
- Payments begin at 10% and are tax free
- Survivor annuity payable <u>if</u> your death is service-connected
- Service Disabled Veterans Insurance (SDVI) policy available to disabled
- Evidence of disability within one year of discharge/retirement

### Family Members


- Veterans 30% or more disabled are also entitled to additional compensation for their dependents Birth certificates, marriage license, etc. should be submitted
  - w/initial claim



## **Combined Rating Table**

- Arrange disabilities from highest to lowest
- Use table to add all disability ratings beginning with the most severe
- After combining all disabilities, the number is converted to the nearest degree divisible by 10
  - 4 rounded down
  - 5 rounded up

### VA Math



In VA Math, 50 + 50 does not equal 100!

## Medical Evidence

- <u>Diagnosis</u> of current disability made by <u>medical professional</u>
- Service medical records may establish current disability
- VA examination may verify current disability



### Conditions Diagnosed after Service

 Must prove link between military service and current disability.
VA healthcare provides evidence
Get an accredited veterans' benefits representative!!!

### Link



Evidence of a direct causative link between incident in service and current disability

#### or

- Medical evidence linking current disability to another, already service connected condition (heart disease secondary to diabetes)
- O% service-connected is important, but not compensable

#### **Vietnam Presumptive**

- B cell leukemia's
- Parkinson's disease
- Ischemic heart disease.
- AL Amyloidosis

#### Stressor



- Event that involved actual or threatened death or serious injury to self or others
- Response involved intense fear, helplessness or horror
- Stressor does not have to occur in combat
- Personal assault, physical attack, torture, automobile accident, plane crash, ship sinking, explosion, natural disasters, etc.

## Individual Unemployablity

- Unable to secure gainful employment
- I service-connected disability rated 60% or more
- 2 or more disabilities totaling at least 70%, with 1 rated 40% or more
- Paid at 100% rate

#### Dependency Indemnity Compensation

- Monthly benefit paid to eligible survivors of certain deceased veterans
  - Died on active duty
  - Died as result of s/c disabilities
  - Totally disabled for last 10 yrs
  - Totally disabled for at least 5 yrs
- Basic Rate \$1,195 per month



### Non-Service Connected

- Disabilities or conditions NOT related to military service
- NOT eligible for compensation
- Do count for pension benefits
  - Wartime veterans
  - Limited or no income
  - 65 or older, or
  - Permanently & totally disabled

## Pension Eligibility



Other then dishonorable discharge

- Served 24 months or full period called to active duty (some exceptions)
- Low countable income includes earnings, disability and retirement payments, interest and dividends, and net income from farming or business of all household members

Pension (con't)




Income limits set annually by Congress

- Veteran alone \$12,463
- One dependent \$16,324

Medical expenses can be deducted

- Veteran alone if exceed \$623
- One dependent if exceed \$816

### Housebound



- Paid in addition to monthly pension
- Must be eligible for pension
- Single permanent disability evaluated as 100-percent disabling AND, due to disability is confined to home, OR,
- Single permanent disability evaluated as 100-percent disabling AND, another disability, or disabilities, evaluated as 60 percent or more disabling

## Aid & Attendance

- Paid in addition to monthly pension
- Must be eligible for pension
- Require aid of another person in order to perform personal functions required in everyday living
- Bedridden
- Cannot protect self
- Nursing home patient
- Blind or nearly blind



#### Accredited Representation

- 87 organizations recognized by VA
- Trained and passed test
- Services at no cost to veteran
- Counseling, gather information, prepare forms, submit claim, interpret letters/decisions, advice, communication with VA
- ~\$7,000 more annually
