John Schells' wife Sherry announced that her first effort to raise money for TMA by sponsoring the "Annual Royal Highlands Central Florida/KIT Bridge Tournament has raised to date close to \$2000 for TMA. Sherry's neighbors along with other contributors from our KIT have been most generous. After a few more announcements we introduced our speakers.



We were very happy to have for this meeting, **Kathy Haviland**, Founder/CEO and president of the "Tri County Senior Outreach Services." It is an organization dedicated to providing care to elderly and disabled. Kathy recognized the difficulty of accessing services needed by senior or disabled individuals, without professional guidance and a care plan for implementing them. For example, where do we start or what do we do if our "Care Partner" has to go out of town for a family emergency? Accessing something seemingly simple like where can I get five



day respite care without having to make lots of phone calls. It would be easier to have

one person to contact. Where can I find help to facilitate my care partner getting in and out of the shower? To this end Kathy is the person who will meet with you and assist you in putting together a care plan. She maintains associations with financial planners, nursing homes, assisted living facilities, Hospice organizations and skilled nursing in home care resources. Kathy does charge a small fee for her services, the amount being determined by the extent of the services. Kathy brought with her a team from several of the areas she talked about and each of them made presentations to us regarding what they can offer to us. Instead it provides all sorts of benefits that can affect the life of an individual while they are still able to live a full life and enjoy it in their home environment. Medicare pays for medication and for 5 days of Hospice house care. This is not a topic most of us want to talk about, but it is wonderful to know they are there if we need them. After our catered lunch and a little catching up we settled into a discussion about what we do to make our life easier around the house, in the car, or whatever we are doing. We talked about exercise, exercise machines, portable bidets, and how to brush your teeth from a wheelchair.

Chris Parsons told us about a product he has purchased called **MOTOmed.** It allows him to sit in his wheelchair and exercise his legs with passive power assisted movement therapy. http://www.motomed.com/en.html

Robert Hazelet showed us a very clever device called a Sanicare Power Bidet. John Schell started the discussion by talking about his quest to have a accessible bathroom including a vanity that doesn't look like a motel room with open plumb-


ing. He actually had a neighbor come in and design a vanity with

drawers and opening that allowed his wheelchair to get him up to the sink. The designer even custom fitted the drawers around sinks and plumbing to allow for maximum use of John also space. talked about the im-

portance of grab bars in areas where he needs to stand and

pivot or bear some weight. On either side of his lift toilet he has affixed grab bars so he can pull in with his wheelchair, lift to a standing position, turn and sit. **See pictures**
