KC KIT MEMBERS SAY "WELCOME" TO OUR CANADIAN VISITORS

On Saturday, October 17, 2009, Gary and Dianne IsRalson made their way southward from St. Albert, Alberta Canada to attend our KC KIT meeting. Gary was diagnosed with inclusion body myositis (IBM) in 2004 in Canada. Soon thereafter Gary decided to do his own research and turned to the USA for any ongoing research and studies. The IsRalson's found a study being conducted in Bethesda, Maryland for a drug called Campath. The study involved several trips to National Institutes of Health

(NIH) and eventually Gary was 1 of 20 patients that would be selected for the study. The first 10 patients received the drug (Campath) and Gary was patient 11, which means he did not receive the drug. There did prove to be several side effects to Campath, so the study was halted.

After more searching, another study appeared on the web which was being conducted at the University of Kansas Medical Center. Gary applied and was accepted for an ongoing study

now being conducted through the Neurology Department, KUMC. The IsRalston's were then put in contact with Laura Herbelin, Research Instructor, University of Kansas Medical Center.

While Gary finds IBM a "very frustrating" condition, he maintains that "one must keep positive, and try to be involved in as much research as possible to assist in studies and eventual a cure for this condition".

Dr. April McVey Presents Information on Muscle Biopsies

Dr. April McVey, Neuromuscular Specialist, University of Kansas Medical Center, attended the October 17, 2009 where she discussed and shared a very interesting and informative power point presentation on muscle biopsies of patients with IBM (inclusion body myositits, DM (dermatomyositis), PM (polymyositis) and NM (necrotizing myopathy).

Dr. McVey discussed how important muscle biopsies are to the proper diagnosis of the various muscles diseases. Each type of myositis has some very distinguishing differences when viewed under the microscope. Therefore, muscle biopsies remain one of the more important tools in the total assessment and diagnosis of a particular muscle disease.

Dr. McVey discussed how she performs muscle biopsies which are usually done at the Landon Center under local anthesiology or some patients may opt for complete sedation with a general surgeon. Following Dr. McVey's presentation, the KC KIT members were allowed time to ask questions.

Much thanks to Dr. McVey for taking her time to attend our meeting and help educate our group on muscle biopsies.

Tony passed away at the age of 79 years after a lengthy battle with inclusion body myositis. Tony is survived by his wife of 55 years, Gladys; daughter Colleen and her husband Hal Galbraith, daughter Mary and her husband Richard Wiggins, son Kevin and his wife Vicki McGrath, daughter Patricia Crawford, daughter Maureen and her husband Carl Schmittgens, brother Daniel and sister-in-law Charlotte McCrath and 12 grandchildren.

Tony entered the United States Navy in 1952 where he served aboard a steam driven vessel, the Daniel A. Joy. On January 23, 1954, Tony and Gladys June Egloff were married in Lemont, Illinois. After relocating to Kansas City ,Tony attended Pharmacy School at the University of Kansas City Pharmacy school, where he graduated with honors. In 1963, Tony and his brother Francis McGrath opened the first McGrath Prescription Shop on Blue Ridge Boulevard. The McGrath brothers went on to open four more prescription shops in the Kansas City area. The McGrath Prescription Shops were also known for being one of their first pharmacies to offer the convenience of drive-up prescription service. Tony was also a longtime member of St. Catherine's Catholic Church.
